

What is a Privacy Policy?

A privacy policy is a statement that discloses some or all of the ways a website collects, uses, discloses, and manages the data of its visitors and customers. It fulfills a legal requirement to protect a visitor or client's privacy.

As awareness and concerns about the protection of personal information is increasing worldwide, it is very important that businesses, both small and large, implement and provide users of their websites with comprehensive privacy policies.

Countries around the world have their own laws with different requirements per jurisdiction regarding the use of privacy policies. You should make sure you are following the legislation applicable to your activities and location.

- What information we collect;

What type of information do you collect?

We receive collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email, and communications); may also include payment details (including credit card information), comments, feedbacks, product reviews, recommendations, and personal profile.

Information Collection, Use, and Sharing

We are the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us via email or other direct contact from you. We will not sell or rent this information to anyone.

- We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g., to book a service request.
- Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy.
- Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number provided on our website:

- See what data we have about you, if any.
- Change/correct any data we have about you.
- Have us delete any data we have about you.
- Express any concern you have about our use of your data

How you collect the information

When you request information on our website, as part of the process, we collect personal information you give us such as your name, address and email address for the purpose of rendering services or request of information thereof. We assume that you agree to the collection of your personal information and that it will be used for the specific reasons stated above only.

- An user is required to give certain information (such as name and email address). This information is used to contact you about the products/services on our site in which you have expressed interest. At your option, you may also provide demographic information (such as gender or age) about yourself, but it is not required.

How you store, use, share and disclose your visitor's personal information

Orders

We request information from you on our order form. To request services and pay, you must provide contact information (like name and address) and financial information (like credit card number, expiration date). This information is used for billing purposes and to fill your orders. If we have trouble processing an order, we'll use this information to contact you.

Communications

For these purposes we may contact you via email, telephone, text messages, and postal mail.

Inform if you use cookies and other tracking technologies

We use "cookies" on this site. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site. For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance their experience on our site. Usage of a cookie is in no way linked to any personally identifiable information on our site.

Some of our business partners may use cookies on our site (e.g., advertisers). However, we have no access to or control over these cookies.
